## APPENDIX TO FEE SCHEDULE

- 1     **Registration fees** are due after the completion of the Intention to Return Form at the end of each academic year.
- 2     **Tuition Payments:** Families are encouraged to pay their tuition in full at the start of a new academic year. However a 10 month payment plan is available. The first payment is due by the 30<sup>th</sup> of each month commencing in August and ending in May.
- 3     **Siblings Discount:** A 5% discount has been applied to the fees represented above for the second child in each family.
- 4     **Referral Credit:** Families will receive a \$50 credit for each child they refer who enrolls at our institution.
- 5     **Constituent SDA:** This refers to members of the *Pine Forge* and *Walnut Street Seventh-day Adventist Churches* who are in good and regular standing.
- 6     **Non-Constituent SDA:** This refers to members of the wider Seventh-day Adventist Church Community.
- 7     **Non- SDA:** This refers to persons who do not hold membership in a Seventh-day Adventist Church.
- 8     **Late Payment Fees:** All accounts for which the agreed payment amount has not been remitted within five (5) days of the due date will attract a late payment fee of \$15.
- 9     **Cash App and Credit Card Convenience Fees:** All payments that are made via Cash App and Credit Cards will attract a fee of 2.75% as charged by the respective companies.
- 10    **Delinquent Accounts:** Accounts are deemed delinquent when the agreed payment amount has not been remitted for sixty (60) days or more. Students will not be allowed to resume classes until the overdue balances have been paid in full.
